Internship Mode: This is a Work From Home & Field-based Internship.

The selected intern will:

- Work remotely/from home for documentation, reporting, coordination and planning.
- Visit tree plantation and project sites for monitoring, supervision and maintenance activities.

- Minimum Qualification: Graduate (Bachelor's degree mandatory) in Forestry, Horticulture, Environmental Science, Agriculture, Natural Resource Management, or allied disciplines.
